TTU Degree Requirements

The RHIM B.A.A.S., the first of its kind in Texas, will serve as a completer program for individuals who earned an A.A.S. degree in culinary sciences or hospitality management from an accredited community college.

1. Hours

- a. Students seeking the 120-hour Bachelor of Applied Arts and Sciences (B.A.A.S.) in RHIM degree must first obtain an Associate of Applied Science degree from an approved institution. Students will complete a minimum of 60 semester credit hours at Texas Tech University beyond the AAS degree.
- b. The program of work includes up to 33 hours of culinary or hospitality credits earned at the community college from which students received their A.A.S. degree.
- c. In addition, Texas Tech University and College of Human Sciences core courses and 40 credits of RHIM program core courses and electives are required, giving students a well-rounded hospitality business education.
- d. A required 400-hour hospitality industry internship counts toward the 1,200-hour work experience needed to earn the B.A.A.S. degree.

2. Core Curriculum

- a. Students must complete the State of Texas core curriculum which consists of a total of 42 semester credit hours as approved by the Texas Higher Education Coordinating Board for Texas Tech University.
- b. Core curriculum courses taken at the sending institution and marked as core on the sending institution's official transcript will transfer to TTU and be applied to BAAS as core curriculum.
- c. Students will select additional approved Texas Tech courses deemed by a BAAS in RHIM advisor as appropriate to the degree.

3. Uniform Graduation Requirements

- a. **Foreign Language Requirement** credit for two years of the same language earned in high school or two semesters (or its equivalent) of a single foreign language at the first-year college level.
 - Students need to submit an official high school transcript when applying to the university documenting language credits earned in high school to determine whether additional language is needed.
- b. **Laboratory Science Requirement** two semester credit hours of science laboratory courses. Labs should correspond with the lectures completed.
- c. **Multicultural Requirement -** In addition to the State of Texas core curriculum, every student must complete at least one 3-hour multicultural course or its equivalent that focuses explicitly on the distinctive subcultures of the United States or on the culture of another society. The following are Texas Common Course Number courses that will apply toward both a core requirement and the TTU multicultural requirement: ARTS 1301; ANTH 2346 or 2351; HUMA 2323; GEOG 1302 or 1303; PHIL 1304; or SOCI 1301. Other course selections are available at TTU for fulfilling this requirement.

4. Additional Notes

- b. The maximum number of transferable semester credit hours from a two-year institution applicable to the degree is 80.
